

## Regarding the processing of your data in connection with the receipt of an offer

You have received an offer from LTA Auto ApS. In this context we process personal data. In accordance with the rules of the General Data Protection Regulation, we must therefore inform you about how we process your data.

LTA Auto ApS has registered personal data about you, if

- you are a potential customer with us or
- you are affiliated with a company that is a potential customer of LTA Auto ApS.

**If you are a contact person at a potential customer** you are urged to share this text with other contact persons at the potential customer who you know already have or will have contact with LTA Auto ApS.

LTA Auto ApS is the data controller for the processing of your data. LTA Auto ApS can be contacted via LTA@LTAauto.com or tel.no. +45 62 22 56 00.

### What data is processed?

We do not process any sensitive data about you, only general data. This comprises potential **customer** master data such as name, address, telephone number and email address.

As a **contact person**, we have master data about you, such as name, telephone number, email address and your job title.

### What is the purpose of processing the data?

There are various reasons for processing data about you:

- to administrate the issue of offers, to include storing of data about you and / or a contact person
- to store data about you for a period after the issue of the offer, for the purposes of documentation

### What is the lawful basis for the processing of the data?

In general, it is illegal to process personal data, unless the data collector has a *lawful basis* for the processing.

At LTA Auto ApS we apply the following lawful basis, depending on whether you are a potential customer or a contact person:

#### **If you are a potential customer:**

The lawful basis for the processing is primarily the agreement between you and LTA ApS for the purchase of LTA Auto ApS services, which naturally involves the processing of data about you, see. General Data Protection Regulation Article 6 paragraph 1, point b.

In addition, the lawful basis may be LTA Auto ApS's legitimate interests in performing certain processing, see General Data Protection Regulation Article 6 paragraph 1, point f. This is the case when storing the data for the purposes of documentation.

**If you are a contact person:**

If you are not a potential customer, but a person affiliated with a company that is a potential customer, then the lawful basis for the processing of data is LTA Auto ApS's legitimate interests in maintaining data about the recipients of offers, including information about company contact persons to facilitate management of the relationship, see General Data Protection Regulation Article 6 paragraph 1, point f. 6 paragraph 1, point b.

**When will the data be erased?**

In general, all data will be erased at the latest 5 years after the end of the year in which the offer was issued. In special cases, where there is danger of a legal dispute with a potential customer or a contact person, all data can be stored for documentation purposes until the requirement is statute-barred or finally dismissed by a court.

**Who is the data shared with?**

The information is generally not shared with third parties. In certain circumstances, particularly in the event of a legal dispute, the information may be shared with lawyers, accountants, courts, public authorities and insurance companies.

**Your Rights**

Under the rules of the General Data Protection Regulation, the data subject has the following rights in relation to LTA Auto ApS:

If you wish to exercise your rights, please contact us.

**The right to view your personal data (right of access)**

You have the right to access the data that we process about you, as well as some additional information.

**Right to rectification (correction)**

You have the right to have any inaccurate data about you rectified.

**Right to erasure**

In special cases, you have the right to have data about you erased before our scheduled normal general erasure.

**Right to restriction of processing**

In certain cases, you have the right to have the processing of your personal data is restricted. If you are entitled to have your processing restricted, such data shall, with the exception of storage, only be processed with your consent or for the establishment, exercise or defence of legal claims or for the protection of the rights of a person or for reasons of important public interest.

**Right to object**

In certain circumstances, you have the right to object to our or lawful processing of your personal data. You can also object to the processing of your data for direct marketing.

**The right to transmit data (data portability)**

In certain circumstances, you have the right to receive your personal data in a structured and commonly used machine-readable format and to have transferred such personal data from one data controller to another without hindrance.

If you think the processing of your data contravenes the rules set forth in the General Data Protection Regulation, you can lodge a complaint with us. If you disagree with our assessment of the case, you can complain to the Danish Data Protection Agency.
